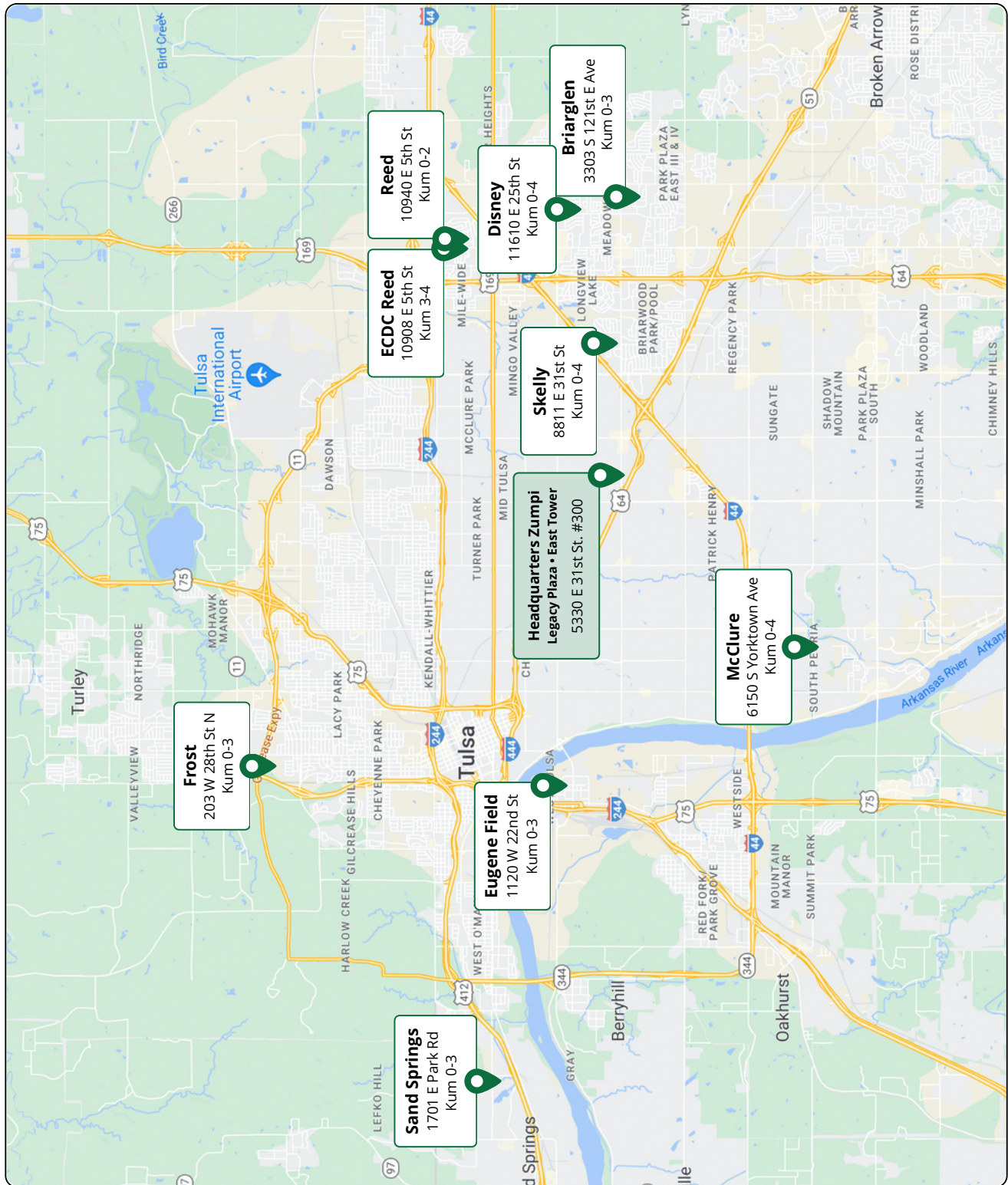

Na FSA in khatta in manpiakkullo huhna leh thuki kuppihna innpan ahi zongin sangphual ah ahi zongin hong neih pih thei a cidam lam, kamphenna, naupang pattazia thusinna, leh adang no innkuan i na kisapte uh hong huh thei hi. Na FSA in nang tawh nasem khawm ding a cidamna lai le adang kisam lai tuamtuam te ahun zui in piak theih nading in zong hong huh ding uhhi. CAP Tulsa in cidamna tawh kisai lai khempueh kaikhawm a kepding kisam a tuate pen no innkuan le sang akah naupang khempeuh huhna ngah theih nading kumpilampan sum huhngetna (funding) ading thupi mahmah hi.

Naupangte akhantoh nading in, innkuanpihte tawh sem khawm dingin laman ung! Nu leh pate kihel theih nading gelnā tampi nei hi ung. Na theihna te na ta ii sangsia tungah hawmsawtna in, na ta ii ki tangsapna zui in amah ngiat ading leh khantoh nading tupna bawl na ah ong thupi pha mahmah ding hi.
